REPORT ON THE DISASTER RELIEF FUND 2019-20

INTRODUCTION

This report gives an account of the operation of the Disaster Relief Fund in 2019-20.

DISASTER RELIEF FUND

2. The Disaster Relief Fund ("the Fund") was established on 1 December 1993 under the Public Finance Ordinance ("PFO") to provide a ready mechanism for Hong Kong to respond swiftly to international appeals for humanitarian aid in relief of disasters that occur outside Hong Kong. The Fund is topped up by the Government of Hong Kong Special Administrative Region ("the HKSAR Government") at the start of each financial year and, as necessary, during the financial year, depending on calls for relief and the size of the Fund balance and commitments.

3. As in the case of other funds set up under the PFO, the Financial Secretary has been designated as the administrator of the Fund. The Financial Secretary has further delegated the power of administering the Fund to the Director of Administration, including the authority to approve each individual disbursement not exceeding \$8 million. The approval of the Finance Committee of the Legislative Council ("LegCo") is required for each disbursement exceeding \$8 million. The Fund is audited by the Audit Commission annually and the audited accounts are submitted to LegCo for information^[1].

4. All grants from the Fund are made on the advice of the Disaster Relief Fund Advisory Committee ("the Committee"), which is chaired by the Chief Secretary for Administration and comprises both official and non-official members. Its terms of reference include providing advice on the policy and practices regarding the disbursement of funds for disaster relief and the size of grants made to specific recipients, and monitoring the use of grants. The membership of the Committee in 2019-20 is at *Annex A*.

OPERATION OF THE FUND

Guidelines and Conditions for Approving Grants

To ensure fair and objective assessment on funding 5. applications, the Committee has devised a set of guidelines and conditions for approving grants. These guidelines and conditions are at Annex B. In view of the upward trend in both the number of relief programmes and funding amount approved by the Fund in recent years, for the purpose of enhancing efficiency in approving grants, the Committee reviewed the guidelines for approving relief items in 2019-20. The Committee noted that relief items and/or item prices proposed by some relief organisations were noticeably different from those commonly adopted by other organisations. However, the organisations concerned were not able to provide justifications (e.g. relevant international standards for humanitarian aid, habits of the victims and standards adopted by local governments of the relief areas^[2]). Hence, the Committee decided to further clarify that in approving relief items, apart from the promptness of relief delivery, it would also take into account whether a relief programme could, on the premise that standards or needs for humanitarian aid were met, make the best use of funding resources to provide appropriate assistance to a greater number of victims.

Monitoring the Use of Grants

6. The Committee has adopted the following measures to monitor the use of grants -

 (a) the relief organisation is required to lay down a relief schedule setting out, among other things, the commencement and completion dates of a programme, and report to the Secretariat of the Committee ("the Secretariat") the critical programme milestones within one month from the respective scheduled dates;

- (b) if the relief organisation has made specific minor variations to an approved relief programme with its delegated authority^[3], it is required to notify the Committee within one month from the effective date of the variations;
- (c) save for the minor variations mentioned in (b) above, should there be signs of deviation from the approved targets (such as the schedule, relief location and type of relief items), the relief organisation is required to obtain prior approval from the Committee;
- (d) the relief organisation is required to obtain at least three quotations in each procurement exercise to ensure proper use of funding for procuring relief items and the procedures should be conducted in a fair and open manner;
- (e) overheads or other administrative costs of the relief programme borne by the relief organisation should not exceed 5% of the grant or 5% of the total expenditure, whichever is less. Such expenditures should not be used to support the daily operation of the organisation;
- (f) the relief organisation is required to display prominently the message that the relief items are "Funded by the Government of the Hong Kong Special Administrative Region" or "Funded by the Disaster Relief Fund, Government of the Hong Kong Special Administrative Region", and provide photographs in the evaluation report as proof of compliance with this requirement;
- (g) the relief organisation is required to submit an evaluation report and an audited account within six months upon completion of the relief programme. The evaluation report submitted should give an overall assessment of the programme targets (including the number of beneficiaries and the time

The level of change for the budget of individual spending items will not be capped.

needed for delivery of emergency relief). The evaluation report and the audited account are examined by the Secretariat before submitting to the Committee for information. The Audit Commission will also inspect the evaluation report and the audited account during the annual audit exercise to ensure that the relief programme is conducted according to the funding requirements; and

(h) the relief organisation is required to provide information in the application to confirm that it has established a code of conduct, disciplinary procedures, recruitment vetting and reporting system to guard against and handle staff misconduct cases properly. In the event of any incident detrimental to the beneficiaries and the Fund, such as sexual harassment or exploitation, abuse, fraud and improper use of the grant, the organisation shall, within two weeks upon such incident coming to its knowledge, provide a brief report to the Secretariat on, inter alia, the nature of the incident and actions taken.

7. In 2019-20, the Committee also reviewed the measures for monitoring the use of grants. In view of the increasing demand for funding, the Committee decided to implement the following new measures to further enhance monitoring -

- (a) if a relief organisation commits a serious violation of grant conditions, it must submit a concrete improvement proposal in addition to providing explanation of the circumstances; and
- (b) when processing the relief organisation's future funding applications, the Secretariat will make recommendations for the Committee's consideration based on the organisation's non-compliance record in the past three financial years.

GRANTS APPROVAL AND MONITORING WORK IN 2019-20

Processing of Grant Applications

8. In 2019-20, 18 funding applications^[4] (22 in 2018-19) were received from relief organisations and all of them (21 in 2018-19) were approved. During the reporting period, grants totalling \$66.78 million (\$65.58 million in 2018-19) were approved for nine organisations (same as that in 2018-19) to conduct relief programmes in seven geographical regions (six in 2018-19) and the number of beneficiaries was estimated to be around 470 000 (around 430 000 in 2018-19). The nine organisations which successfully applied for funding were Adventist Development and Relief Agency China (Hong Kong) (three cases), Oxfam Hong Kong (three cases), Amity Foundation, Hong Kong (two cases), CEDAR Fund (two cases), Habitat for Humanity Hong Kong (two cases), Plan International Hong Kong (two cases), World Vision Hong Kong (two cases), Hong Kong Red Cross (one case) and Save the Children Hong Kong (one case).

9. A summary of the relief programmes with grants approved is as follows -

Of the programmes approved, 55.56% (ten cases) were for the relief of cyclone or typhoon victims and 44.44% (eight cases) were for the relief of flood victims. Of the grants approved, 67.71% (\$45.22 million) were used for relief programmes in Asia (apart from the Mainland of China), 25.49% (\$17.02 million) were used for relief programmes in Africa and the remaining 6.80% (\$4.54 million) were used for a relief programme in the Mainland of China. A list of programmes with approved grants, related photographs and statistics are at *Annex C*.

Application Processing Time

10. Grants are made from the Fund to provide swift response to international appeals for humanitarian aid for relief to disasters that occur outside Hong Kong. From receipt of full information from the applicant to giving notification of the result, the target time for processing an application by the Secretariat is within 12 working days. In 2019-20, all applications were processed within the target timeline. The average processing time of the 18 applications was eight working days.

Processing Applications for Programme Variations

11. From receipt of full information from the applicant to giving notification of the result, the target processing time is within eight working days for a major variation application and within three working days for a minor variation application. In 2019-20, apart from 13 notifications of minor variations effected by relief organisations themselves under their delegated authority, the Committee received two major variation and 13 minor variation applications. All such applications were processed within the target timeline. The average processing time of the two major variation applications was six working days, while that for the 13 minor variation applications was one working day. Since the designated purpose of the grant remained unchanged and the variations were justifiable, all such applications were approved. Of the 13 minor variation cases handled by the organisations under delegated authority, all fulfilled the requirement of not exceeding the 20% variation limit.

Evaluation Reports and Audited Accounts from Grant Recipients

12. The Secretariat received and examined a total of 22 evaluation reports with their audited accounts due for submission in 2019-20 (including 17 reports on grants approved in 2018-19), and then submitted them to the Committee for information. All these reports were accepted for having met the prescribed targets^[5] as follows -

- (a) use of grants all grants were used for the approved purposes and in compliance with the condition that not more than 5% of an individual grant or total expenditure (whichever is less) should be used to cover overheads or other administrative costs. Among the 22 completed relief programmes, 18 recorded a balance of unused grants totalling about \$4.03 million which was returned to the Fund;
- (b) number of beneficiaries all these 22 relief programmes achieved the target number of beneficiaries^[5] and provided emergency relief to some 520 000 victims in aggregate. The relief items received by the beneficiaries under these programmes included food (such as rice, flour, cooking oil, beans, seasonings, canned food, biscuits and drinking water), blankets/quilts, floor mats/sleeping mats, mosquito nets, kitchenware, lighting tools, water filters, water purification tablets, oral rehydration salts, hygiene items, household items, clothing, education kits, emergency classroom kits, temporary shelter materials and tools as well as mobile toilets; and
- (c) timely completion of the programmes all relief programmes were delivered according to the approved schedules^[6].

The annual audit of the Fund conducted by the Audit Commission included auditing the accounts and operation of the Fund as well as these reports. All the evaluation reports and audited accounts had been duly completed in accordance with the funding requirements. The audited accounts had also passed the Audit Commission's annual inspection.

13. With regard to programmes approved in 2019-20 with evaluation reports and audited accounts due for submission in 2020-21, the Secretariat will closely monitor the situation and thoroughly examine the relevant documents on receipt before submitting them to the Committee for information. The outcome of such examination will be stated in the next annual report of the Fund.

GRANTS APPROVED SINCE ESTABLISHMENT OF THE FUND

Summary

14. From the establishment of the Fund to 31 March 2020, the Committee received a cumulative total of 523 applications by relief organisations for grants from the Fund. Of this total, 437 (83.56%) applications for grants amounting to \$1,089.7 million were approved. For the remaining 86 applications, 61 (11.66%) were rejected for noncompliance with the guidelines for grants and 25 (4.78%) withdrawn by the organisations. In addition, 22 grants amounting to \$994.82 million were made to governments outside Hong Kong. In overall terms, 18 organisations and nine governments/authorities had received grants totalling \$2,084.52 million from the Fund. The beneficiaries were of floods. earthquakes/tsunamis, mostly victims typhoons/cyclones/hurricanes and droughts/famines. Relevant information and statistics are set out in the ensuing paragraphs.

15. Given the upward trend in both the number of approved applications and funding amount in respect of grants allocated to relief organisations, the annual appropriation of the Fund had been increased from \$50 million on its establishment to \$80 million in 2016-17 and further up to \$100 million in 2019-20.

Distribution of Grants by Recipient

16. Among the 18 relief organisations receiving grants from the Fund, World Vision Hong Kong, Oxfam Hong Kong, The Salvation Army, Amity Foundation, Hong Kong and Hong Kong Red Cross were the top five recipients, with approved grants totalling \$836.41 million, which accounted for 40.12% of the total grants approved by the Fund. Statistics on the distribution of grants by recipient are at *Annex D*.

Distribution of Grants by Beneficiary Geographical Region

17. Since the establishment of the Fund, the beneficiary geographical regions in order of cumulative grant amounts disbursed are the Mainland of China, other places in Asia, Africa, Latin America, Oceania and Europe. Statistics on the distribution of grants by beneficiary geographical region are at *Annex E*.

Distribution of Grants by Nature of Disaster

18. Of the programmes approved on the advice of the Committee, 36.38% (167 cases) were for the relief of flood victims; 30.07% (138 cases) for earthquake/tsunami victims; 15.03% (69 cases) for typhoon/cyclone/hurricane victims; 10.68% (49 cases) for drought/famine victims; 5.01% (23 cases) for snowstorm victims; and 2.83% (13 cases) for victims of other disasters. Statistics on the distribution of grants by nature of disaster are at *Annex F*.

Guidelines for Grants from the Disaster Relief Fund (March 2016)

I. <u>Coverage</u>

- (1) Grants should only be made in cases of a specific disaster¹, not an on-going problem².
- (2) Grants should only be made in cases of disasters of such nature and scale that stimulate a response by the international community.
- (3) The relief support should be confined to time-critical response in the emergency context.

II. <u>Assessment of Proposals</u>

- (4) Grants should be made in response to-
 - (a) an appeal made to the international community by a government or a relief organisation for disaster relief aid in the country or locality concerned; or
 - (b) an application submitted by a locally registered relief organisation³ for a disaster relief project being or to be carried out by the organisation. Retroactive funding is not supported.
- (5) The appeal/application should be based on humanitarian grounds. Political considerations will not be taken into account.
- (6) The appeal/application should have received a measure of public support in Hong Kong.
- (7) Any application by a relief organisation should be supported by a proposal outlining the nature and scale of the aid project, the number and type of beneficiaries and the size of grant required.

¹ Including natural disasters and non-natural catastrophes, e.g. explosion of nuclear/chemical facilities and terrorist attacks causing substantial damages and casualties.

² Such as refugee problems, wars or post-disaster rehabilitation/reconstruction.

³ The relief organisation should be a charitable organisation exempted from tax under Section 88 of the Inland Revenue Ordinance, Cap. 112.

- (8) The relief organisation should have demonstrated a sound track record in providing similar types of disaster relief services and activities.
- (9) The size of the grant should be sufficient to make an impact.
- (10) When there is more than one application of a similar nature and for the same disaster, regard should be given to the likely number of beneficiaries, the promptness with which the relief may be provided and the nature of the relief to be provided.

III. Conditions of Grant

- (11) Individual grants should take the form of one-off cash payments.
- (12) The grant should be given to the government concerned or to a reputable relief organisation in the field.
- (13) Up to 5% of the grant may be used to cover overheads or other administrative costs. The rest should be spent entirely on disaster relief services and activities.
- (14) The government/relief organisation concerned should be required to submit an evaluation report and/or an audited account as appropriate to the Government of the Hong Kong Special Administrative Region on the use of the grant within a specified period.










