#### **Points to Note**

# 1. Eligibility of Community Lawyers

- (a) Lawyers who have at least two years' post-qualification experience and holding a current practising certificate can join the Scheme in their personal capacity on a probono basis.
- (b) Law firms can also participate in the Scheme and assign eligible lawyers to enrol as community lawyers. Participating law firms will be required to appoint a coordinator to liaise with the Scheme's Centre-in-charge on the preparation of a duty roster of community lawyers.

#### 2. Advice Sessions and Honorarium

- (a) The operating hours of the Scheme's office will be from 8:45 am to 1:00 pm and 2:00 pm to 6:00 pm, Mondays to Fridays (except public holidays). Advice sessions will be conducted within these office hours at the Scheme's office.
- (b) Community lawyers will be invited to attend a full session of four hours or a half session of two hours to conduct advice sessions on a need basis.
- (c) An honorarium of \$1,000 per four-hour session, or \$500 per two-hour session, will be offered to community lawyers. The honorarium can be waived if the community lawyer so wishes.
