In the past three years, reports on 41 completed research studies commissioned by CPU were not published or released; 10 were published. As regards the 12 research studies currently still in progress, CPU will consider the circumstances and nature of the studies before making a decision. The total expenditure of the 41 studies in the past three years was \$10.509 million.

Regarding the research projects undertaken by the Central Policy Unit (CPU), the Administration was requested to provide the following information:

- (a) feasibility of setting a deadline for publication of reports which had already been compiled but not yet published;
- (b) mechanism of selecting an institution to conduct research; and
- (c) number of cases involving the award of consultancy contracts to research institutions or other parties without going through open tenders in the past three years, if any, and the justification for doing so.

Asked by: Hon. CHAN Wai-yip, Albert

Reply:

- (a) In the past three years, reports on 41 completed research studies commissioned by CPU were not published because they are for internal reference only, and we have no plan to publish these reports either now or in the future.
- (b) Stores and Procurement Regulations (SPR) 280 provides that bureaux and departments should invite written quotations from not less than five contractors for procuring services with a value exceeding \$50,000 but not exceeding \$1.3 million. If bureaux and departments find that due to limited supply in the market or other full justifications, it is not possible to invite the minimum number of quotations required or an invitation of less than the minimum number of quotations required has to be made, prior approval must be sought from an authorised officer before inviting proposals. After obtaining the quotation(s), approval from another authorised officer is needed for the acceptance of an offer. This requirement aims to ensure that the officer who selects contractors and/or approves the invitation of quotations from contractors is not the officer authorising the acceptance of the offer for that procurement.

- (c) In the past three years, all 63 consultancy studies were commissioned to research institutions in accordance with SPR 280. For details, please see paragraph (b) above.
